

**VILLAGE OF ARNOLD  
ORDINANCE NO. 399**

**AN ORDINANCE PROVIDING FOR THE REVISION OF ELECTRICAL RATES TO BE CHARGED FOR SERVICE FROM THE VILLAGE OF ARNOLD; TO REPEAL ALL ORDINANCES OR SECTIONS OF ORDINANCES IN CONFLICT HEREWITH; TO PROVIDE FOR A TIME WHEN THIS ORDINANCE SHALL TAKE EFFECT.**

WHEREAS, THEREFORE, BE IT ORDAINED BY THE CHAIRPERSON AND THE BOARD OF TRUSTEES OF THE VILLAGE OF ARNOLD, CUSTER COUNTY, NEBRASKA:

**SECTION 1:** MUNICIPAL ELECTRICAL SYSTEM; RATES. Pursuant to the Arnold Municipal Code Chapter 3-306, effective for all services rendered after July 15, 2010, the charges for all electric service shall be revised as follows:

**RESIDENTIAL**

**AVAILABLE:** Within established Service Area of Village of Arnold, Nebraska.

**APPLICABLE:** To single-family residences, individually metered apartments and rooming houses for all mixed domestic and non-domestic purposes when all service is supplied through a single meter. Customers desiring single meter service to multi-family units must request such service in writing. Approval will be granted only when individual metering is not practical. Usages at the same meter location whose usage exceeds 10,000 kWh for three consecutive months shall be transferred to the applicable general service rate.

**CHARACTER OF SERVICE:** AC, 60 Hertz, 120/240 volt, three (3) wire, single-phase or three-phase; or 120 volt, two (2) wire.

## **IRRIGATION RATES**

**AVAILABLE:** Within established Service Area of Village of Arnold, Nebraska.

**APPLICABLE:** To seasonal irrigation service to Customers served from existing single or three-phase distribution lines, whose entire requirements are taken through one (1) meter.

**CHARACTER OF SERVICE:** AC, 60 cycles, single or three-phase, at any of the Village's standard voltages (35,000 volts or less) where the service may be supplied by a single power transformation

**SUMMER SEASON:** Irrigation customers are subject to three month minimum summer customer charge. There is no reconnect fee on irrigation.

## MUNICIPAL

**AVAILABLE:** Within established Service Area of Village of Arnold, Nebraska.

**APPLICABLE:** To any service owned by the Village of Arnold, Nebraska for lighting purposes where all service is taken through a single meter at one location.

**CHARACTER OF SERVICE:** AC, 60 Hertz. 120 volts or 120/240 volts, single-phase; or at any of the Village's standard distribution voltages, as available.

## **GRAIN DRYING SERVICE**

**AVAILABLE:** Within established Service Area of Village of Arnold, Nebraska.

**APPLICABLE:** To any Customer for separately metered grain drying purposes where all service is taken through a single meter at one location.

**CHARACTER OF SERVICE:** AC, 60 Hertz. 120 volts or 120/240 volts, single-phase; or at any of the Village's standard distribution voltages, as available.

**POWER FACTOR:** The customer will be expected to maintain a power factor of 95 percent lagging or better. If the measured power factor is lower than this, the customer will be given 90 days to correct. If the power factor is not corrected the monthly bill shall be increased by the quotient of .95 divided by the actual power factor expressed as a decimal.

**INSTALLATION OF DEMAND METER:** At the option of the Village, a demand meter may be installed on any Customer for ascertaining loads.

**MINIMUM BILL:** \$1.00 per kVA of capacity installed at customer's request. Payment of kVA minimum entitles the consumer in all cases to use the number of kWh corresponding to the kVA minimum. 5 kVA is supplied by the Village without charge.

## **GENERAL SERVICE**

**AVAILABLE:** Within established Service Area of Village of Arnold, Nebraska.

**APPLICABLE:** To any Customer for lighting, heating and power purposes where all service is taken through a single meter at one location, and where the Customer's monthly usage exceeds 10,000 kWh, for three (3) consecutive months.

**CHARACTER OF SERVICE:** AC, 60 Hertz. 120 volts or 120/240 volts, single-phase; or at any of the Village's standard distribution voltages, as available.

**POWER FACTOR:** The customer will be expected to maintain a power factor of 95 percent lagging or better. If the measured power factor is lower than this, the customer will be given 90 days to correct. If the power factor is not corrected the monthly bill shall be increased by the quotient of .95 divided by the actual power factor expressed as a decimal.

**INSTALLATION OF DEMAND METER:** At the option of the Village, a demand meter may be installed on any General Service Customer for ascertaining loads.

**MINIMUM BILL:** \$1.00 per kVA of capacity installed at customer's request. Payment of kVA minimum entitles the consumer in all cases to use the number of kWh corresponding to the kVA minimum. 5 kVA is supplied by the Village of Arnold without the kVA charge.

## **GENERAL TERMS & CONDITIONS**

**PRODUCTION COST ADJUSTMENT:** ALL RATES INCLUDED HEREIN ARE SUBJECT TO PRODUCTION COST ADJUSTMENT. The Village, at its sole option, may include any deviation in cost, either as a credit or adder, to all service under these rates. The adjustment shall be calculated in accordance with standard Village policies and shall include adjustment for losses.

### **DEFINITIONS:**

**kW** – shall mean peak kilowatt demand.

**kWh** - shall mean total kilowatt hour consumption per period.

**Summer** - shall mean the usage between May 15<sup>th</sup> to September 15<sup>th</sup>.

**Winter** - shall be the balance of the year.

**SERVICE POLICIES:** All rates and services included herein above are subject to the standard service policies of the village.

**CONTRIBUTIONS TO AID CONSTRUCTION:** If the Village is required to construct new facilities to serve the electrical requirements of a new customer or an existing customer that requires a larger service, that customer will be required to pay the appropriate meter loop fee and 50% of all expenses incurred by the construction including labor.

**METER LOOP FEES:** For new service locations, the following meter loop fees will be applied.

Single Phase: \$300

Three Phase: \$500

**EARLY PAYMENT DISCOUNT:** All payments received by the 15<sup>th</sup> of the month will receive a 5% discount

**DELINQUENT BILLS:** All bills are delinquent after the 15<sup>th</sup> of the month.

**DISCRIMINATION PROHIBITED:** No service shall be provided under any other rate than as provided in these articles.

**SECTION 2:** Repeal: All ordinances or portions of the ordinances in conflict herewith are hereby repealed.

**SECTION 3:** When Operative: This ordinance shall be full force and effect from and after its passage, approval, and publication as provided by law and village ordinance.
